Construction and Commissioning Update

Although the erection of the turbines has been completed, the construction team remain onsite finalizing civil works and preparing for the transition to the operational phase of BB2.

Our major electrical contractors will be back onsite in July finalizing work on the transmission lines, preparing them for the energization of the Berrybank 2 turbines, which should occur later in July.

Golden Plains Shire Council has continued the maintenance on the Berrybank-Wallinduc road; this work involves improving the shoulder of the surface to minimize the drop off.



Community Engagement Update

Neighbour Deeds

The **Community Engagement and Benefit Sharing Plan (CEBSP)** implemented in Berrybank 2 includes a **Neighbour Benefit Sharing Program**. This program provides a voluntary deed to **neighbours within 2km of the wind farm**. The purpose of the deed is to share the financial benefits of the wind farm with the closest neighbours, who may be impacted by the activities at the site during the construction and operation periods, in order to contribute to the local community as good long-term neighbour in the area. This contribution can be used to offset these impacts, if any, or to the discretion of the neighbours. The voluntary deed is individually signed with each neighbour and is available at any time during the construction and operational period.
