Berrybank 1 Wind Farm: Operations update

- Currently the service team is completing the 2 yearly service of the towers.
- Availability continues to be above 99%.
- Noise monitoring has started again with units being deployed around the wind farm. This is a 6-week data collection process per unit.
- Nature Advisory has just finished another round of crop and fauna inspections as per the planning permit.

Berrybank 2 Wind Farm: Construction update

- 22 of the 26 turbines have completed their five-day reliability test.
- Turbine 62 has been dismantled and is the process of being rebuilt.

The Story of Turbine 62

Turbine 62 is the closest wind turbine to the Hamilton Highway on the south side.

Last year, after an abnormal wind episode during the assembly of the tower sections, the foundation was tested and it was decided to dismantle those sections and replace the foundation in order to ensure a high-performance standard for the whole life of the turbine.



After the new reinforcing was in place (pictured), the new foundation was poured on the 11th of February and needed nearly seventy concrete trucks coming from Geelong and Colac to deliver the nearly five hundred cubic metres of concrete needed for the foundation.

The turbine is now fully re-assembled with the crew working on completing the internal fit out. We are hoping that Berrybank 2 will be operational in the coming weeks,

Residents of Smythesdale and surrounds once again have access to dedicated health services at "The Well"

As part of a Golden Plains Shire Council's initiative, two medical practitioners are now operating on site, with \$50,000 of support from the State Government, and another \$50,000 from Global Power Generation Australia operators of the Berrybank 1 and 2 wind farms. Member for Buninyong Michaela Settle said local health services are integral to regional communities.



The facility had been without a medical practitioner following the departure of Ballarat Community Health earlier last year.

The Well's clinic rooms have been fitted out with new equipment and amenities, with plans to incorporate allied health and podiatry alongside general practice. An independent clinic group have taken on the lease and are operational now.

Community Engagement Committee

The Berrybank Community Engagement Committee is a body established by GPG to provide a forum for open discussion between representatives of the Company, the community, the local councils and other key stakeholders on issues directly relating to the project.
